# Qualification Rules

## Current TIENS Distributors

### New Distributors

(that sign-up during the qualification period)

- Conduct at least 15 OPP each month during the qualification period.
- Photo / Video evidence is required for every OPP conducted. *Please use OPP evidence form*
- Develop at least 10 new active Distributors in the personal group within the qualification period (direct or placement sponsor)
- All participants must achieve active Distributor status during the qualification period.
- Active Status - Distributor must make monthly PV purchase according to Compensation plan.
- Current Distributors must be min 4 Star by the end of the qualification period.
- New Distributors who join TIENS after 26th November 2015 must advance to 4 Star within the qualification period.



## **Video must be received by TIENS UK Branch by 25<sup>th</sup> April 2016**

### **Video Recording Requirements**

- The video should be 40 minutes, not longer.
- The standard approved OPP presentation provided by Tiens
- The OPP should be conducted with audience. The number of participants is not specified, but full room always makes good impression. Only one DS. can perform OPP to the same audience
- Be well-groomed and smartly dressed
- Be energetic and use proper gestures

### **Recording Procedure**

- Adopt natural light, incandescent lights or lights for shooting and ensure that the video contains no colour shift and is neither too bright nor too dark
- Make the audio and video clear and inclusion-free and ensure the recording quality
- Focus on close-up views, waist shots and full figure shots and appropriately add the images of on-the-spot students to the video
- Try to ensure that the placing of the camera could realize multi-angle switching without chromatic aberration.
- Record the performance of the contestant throughout the competition.



# 4<sup>th</sup> OPP Incentive Program Terms and Conditions

- To participate in this competition Distributor must fulfil pre-qualification criteria, fill in the application form, and provide 1 portrait document format photo.
- All Participants must develop 10 new DS. in their personal group during qualification period.
- Current Distributors must be min 4 Star by the end of the qualification period.
- Current Distributors must maintain active qualification during the qualification period.
- New Distributors who join TIENS after 26 November 2015 must advance to 4 Star within the qualification period
- All Participants must provide Photo/Video evidence of the 15 monthly OPP required.
- Each participant presentation will need to be video-recorded.
- By taking part in contest participants give full consent to the digital recording, publication and re-production via Tiens UK and Tiens Global channels.
- The participating videos are live recordings of OPP meeting. The OPP should last 40 minutes – no longer. The stage and image of trainees on the site will be included in the video.
- Participants are responsible for inviting the audience and recording the OPP. Video must be recorded between 1st -25th April 2016.
- Country Level Assessment will be conducted by National Assessment Committee: Manager of the participating country; Members - the person in charge of national branch education, high-level active network leader: Advisor board members.
- The Country Winner will be awarded:
